GHANAIAAN AND MOROCCAN NATIONALS

IN RECIPROCITY FOR THE WAIVER OF MOROCCAN ENTRY VISAS FOR HOLDERS OF GHANAIAAN ORDINARY PASSPORTS, I AM DIRECTED TO CONVEY THE MINISTRY'S DIRECTIVE THAT ALL MOROCCAN NATIONALS TRAVELING TO GHANA SHALL BE ISSUED WITH **GRATIS VISAS**, EFFECTIVE **21ST JULY 2025** AS GHANA IS YET TO INTRODUCE AN ELECTRONIC TRAVEL AUTHORIZATION (ETA) SYSTEM.


2. AS PART OF AN ARRANGEMENT REACHED BETWEEN THE REPUBLIC OF GHANA AND THE KINGDOM OF MOROCCO, GHANAIAAN NATIONALS HOLDING ORDINARY PASSPORTS NO LONGER REQUIRE A VISA TO ENTER MOROCCO, **EFFECTIVE 6TH JUNE 2025**. INSTEAD, GHANAIAAN TRAVELLERS ARE REQUIRED TO OBTAIN AN **ELECTRONIC TRAVEL AUTHORIZATION (ETA)** BY COMPLETING AN ONLINE APPLICATION VIA THE OFFICIAL PLATFORM: **HTTPS://WWW.ACCES-MAROC.MA** PRIOR TO TRAVEL.

3. THE ETA IS FREE OF CHARGE AND GRANTED TO ALL ELIGIBLE APPLICANTS. IT IS TYPICALLY ISSUED WITHIN TWENTY-FOUR (24) TO SEVENTY-TWO (72) HOURS. HOWEVER, APPLICANTS ARE ADVISED TO ALLOW FOR A LONGER PROCESSING TIME IN THE EVENT OF NATIONAL HOLIDAYS OR UNFORESEEN DELAYS.

4. INDIVIDUALS AGED FIFTY-FIVE (55) YEARS AND ABOVE ARE EXEMPT FROM THE ETA REQUIREMENT AND MAY TRAVEL TO MOROCCO WITHOUT OBTAINING PRIOR AUTHORIZATION.

5. IT WOULD, THEREFORE, BE APPRECIATED IF ALL MISSIONS COULD COMMENCE THE ISSUANCE OF GRATIS VISAS TO MOROCCAN NATIONALS WITH IMMEDIATE EFFECT.

6. PLEASE ACCEPT THE ASSURANCES OF OUR HIGHEST CONSIDERATION.
